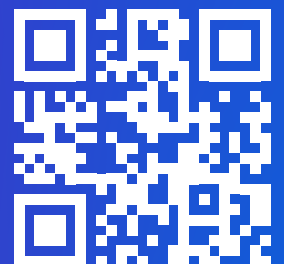
Architecture diagram
